

BOARD OF COMMISSIONERS AND DIRECTORS PT TASPEN (PERSERO)



President Director : Agus Haryanto, SH, MA, PhD

Agus Haryanto finished his study on Law Faculty, University of Indonesia, in 1982. In 1987 he got scholarship in Colorado University, USA. He achieved degree on *Master of Arts in Economics* and *Doctor of Philosophy (PhD) in Economics* on 1986 and 1991.

Arrived at Indonesia, Agus sat as Head of Sub-Directorate of Treasury Administration at Directorate General of Budget in Department of Finance (1991-1992). One year ahead, he held position as Head of Monetary Analysis Bureau, Institute of Monetary and Finance Analysis. In 1993-1998 he received a responsibility as Head of Public Relation and Legal Bureau. His career at Department of Finance developed continuously by holding position as Secretary General twice, in 1998-2000 and 2002-2004.

Agus' wide perspective was then examined by his position as Executive Director of Asian Development Bank representing Cook Islands, Fiji Islands, Indonesia, Kyrgys Republic, New Zealand, Samoa and Tonga (2004-2007). After the duty, he came back to Department of Finance as Assisted Official (Pejabat Diperbantukan) at Secretariat General. In 2008 he was pointed as TASPEN President Director.

Director of Human Resource : Drs Karsidi, MM



Born in 10 April 1954, Karsidi finished his study at Faculty of Social and Politic/State Administration at University of Sam Ratulangi, Manado in 1981.

He had attended various education and training programs, both inside and outside the country, for instance Live Insurance in Tokyo (1994); Assessment Management in Bandung (1997); Service Excellent in Jakarta (2002); and Managing Beliefs and Values (2004).

His career started at Department of Finance by holding position as Head of Development Sub-Section in KPN Manado. Then he sat as Section Head of Budgeting in KPN
